Text of the Proposed Amendments:

Shall section 2-2 of the town charter be amended to state: “The Town Council shall consist of an at-large Mayor and eight Councilmembers, each of whom shall be elected from the district in which he or she resides.”; amending 2-5(a) to read: “The At-Large Mayor shall serve no more than two four-year terms. At the organizational meeting provided for in Section 2-3(c), the Council shall elect by majority vote of the entire Council one of its members as Mayor pro-tem who will serve until the next organizational meeting unless removed by a majority vote of the entire Council.”; in section 2-6 adding “or Mayor” after “Councilmember”; in section 2-7, “and Mayor” shall be added after “every councilmember”; in section 2-3(b) adding “and Mayor” after “The Councilmembers.”

Such amendments are sought to be submitted at a special coordinated election in November 2017.
